ANNUAL WAIVER, RELEASE AND ASSUMPTION OF RISK

READ THIS DOCUMENT CAREFULLY AS IT AFFECTS YOUR LEGAL RIGHTS

In consideration of my being permitted to join the Penticton Outdoors Club and to participate in hikes/skiing and activities offered by the Penticton Outdoors Club, (all of which are now referred to as “the activities”), I hereby for myself, my heirs, executors, administrators and assigns, release and forever discharge and agree to indemnify the Penticton Outdoors Club, its members, executive, hike/ski leaders, and agents and representatives (all of whom shall be referred to as “the Penticton Outdoors Club”) from and against all claims, actions, costs, expenses and demands by reason of any damage, loss, death, or injury to my person or property, howsoever caused, arising out of or in conjunction with my participation in the activities, notwithstanding that the same may have been contributed to or occasioned by the negligence of the Penticton Outdoors Club.

I recognize and acknowledge that participation in the Penticton Outdoors Club activities involves inherent hazards, risks, and dangers including, but not exclusively, such hazards as:

1. Sudden changes in, and extremes of, weather conditions.
2. Falls on slippery or steep terrain, including rocks, snow and ice.
3. Terrain difficult to negotiate, including poor trails, dense bush, and rough and slippery ground.
4. Becoming lost in mountains and remote terrain.
5. All other risks, hazards and dangers that may cause discomfort, damage, injury, loss or death to my person or damage to my property.

I also recognize and acknowledge that the following events and conditions can cause or contribute to the inherent risks, hazards, and dangers of the activities:

1. Inappropriate or inadequate equipment or clothing.
2. Poor or inadequate physical fitness or health.
3. Failure to obey the directions of the hike/ski leader.
4. Failure to exercise good judgement or pay due care and attention.

I agree to assume all such risks, hazards and dangers, and further agree to bear all costs of rescue and treatment rendered to me, or for my benefit, arising from the activities.

I have read this indemnity and release of liability, and understand and accept its terms.
